SCOPE OF WORK

Supply and installation of surging machine for FOMIL Coir Composite Board Factory, Kanichukulangara, conforming to the specifications available in the tender document.

GENERAL INSTRUCTIONS:

- a. The tender is invited from the suppliers/ manufacturers supply and installation of surging machine for FOMIL Coir Composite Board Factory, Kanichukulangara, conforming to the specifications available in the tender document. The tender is invited in single cover system. Prospective bidders willing to participate in this tender shall submit there tenders in sealed cover within the time stipulated in this tender .
- b. The lowest offer made in response to this tender, when accepted by Foam Mattings India Ltd Alappuzha will constitute a contract between the parties.

SUBMISSION OF TENDER:

The interested bidders should submit their lowest rates for supplying the machines as per the specification in the tender.

CLEAR UNDERSTANDING:

When a tenderer submits his tender in response to this document, he will be deemed to have understood fully about the requirements of the terms and conditions of the tender.

VALIDITY OF OFFER:

The offered rate will be valid for a period of six months from the date of tender finalizing. However FOMIL reserves the right to cancel or extend the tender period at any time or invite fresh quotations/ tenders for new purchase if the supplier fail to deliver the item in time or as per the fixed price.

PRICE:

- The rate quoted shall be for three nos of machines.

- The rate should be inclusive of transportation charges so as to deliver the material at FOMIL- Coir Composite Board Factory, at Kanichukulangara.
- The quoted price shall be fixed and firm and escalation on any account shall not be acceptable till the completion of supply of the entire ordered quantity.
- No additional payment will be released other than the quoted rate.

TRANSPORTATION:

The successful tenderer shall make his own arrangements to deliver the material at company without any delay. Transportation cost should be included in the offered rate.

PAYMENT TERMS:

- 100% Payment shall be made only after the supply of materials as per the order.
- However advance payment shall be released against submission of bank guarantee for equal amount from any nationalized bank or a bank cheque for equal amount.
- Please note that, payment shall be made only for the actual quantity of the material accepted at our end. Any rejected/damaged material will not be considered for the payment.

SPECIFICATION OF MATERIAL:

- The machine should be capable to overedging the latex backed carpets, rugs, blankets, mats made of cotton, wool, jute mattings etc.
- The machine should be having the spinning speed of 3000 spm.
- Preferred makes ; Daimoku, Fucen, Tiatan.
- The supply should include machine with its frame work for supporting the motor & machine, table of minimum 1 mtr length and .5 mtr width.
- Necessary safety guards to safeguard the workers and materials. All the specification mentioned above must be strictly followed during the supply of materials.

GUARANTEE/WARRANTY

The Machine shall be guaranteed by supplier against faulty design, defective materials and workmanship and towards their performance, for a warranty period of 1 (One) year from the date of handing over of the machine.

The bidder should assure the quality of equipment supplied and attend the defects/complaints/malfunctioning of the unit, if noticed during the guarantee period which happens due to the poor quality of the machine.

EMD AND TENDER FEE

An amount of Rs.4500.00 (Rupees Four thousand five hundred only) is to be paid as EMD along with the tender. The EMD shall be paid as Demand Draft of same amount infavour of Managing Director payable at Alleppey or the same amount shall be paid at company cash counter, in such case the receipt of the payment shall be submitted along with the tender. The EMD amount is refundable. The EMD of unsucessfull bidders will be released after issuing work order to the

successful bidder and the EMD of successful bidder will be released after completing the supply of the machine as per the tender document.

An amount of Rs.1062.00 (Rupees one thousand sixty two only including 18% GST) is to be paid as tender fee along with the tender. The tender fee shall be paid as Demand Draft of same amount in favour of Managing Director payable at Alleppey or the same amount shall be paid at company cash counter, in such case the receipt of the payment shall be submitted along with the tender. The tender fee is non refundable and will not release the amount in any case.

GENERAL CONDITION:

- Foam Mattings (India) Ltd reserves the right to call for any further information.
- Any information furnished by the agency found to be incorrect at any stage would render their proposal being declared ineligible.
