VALIDITY OF OFFER:

The offered rate will be valid for a period of 45 days from the date of tender finalizing. However FOMIL reserves the right to cancel the tender at any time or invite fresh quotations/ tenders for new purchase if the supplier fail to deliver the item in time or as per the fixed price.

PRICE:

- The rate should include the cost of loading charges, and transportation charges. so as to deliver the materials safely at Foam Mattings (India) ltd, PB No 4619 Beach road Alappuzha, Kerala, as per the specification mentioned in this tender.

- The price quoted will be valid for a period of 45 days from the date of tender finalizing.
- The rate quoted should be for supplying coir yarn per Kg as per specification in the tender document.
- The quoted price shall be fixed and firm and escalation on any account shall not be acceptable till the completion of supply of the entire ordered quantity.
- No additional payment will be released other than the quoted rate.
- GST should be mentioned separately.

TRANSPORTATION:

The successful tenderer shall make his own arrangements to deliver the material at company without any delay. Transportation cost will be borne by FOMIL.

PAYMENT TERMS:

- 100% Payment shall be made only after the supply of materials as per the order.
- Please note that, payment shall be made only for the actual quantity of the material accepted at our end. Any rejected/damaged material will not be considered for the payment.

SPECIFICATION OF MATERIAL:

- The ASM coir yarn should be having 140 to 160 mtr runnage per Kg.
- Approximately 11,000 kg of coir yarn is to be supplied against this tender.

All the specification mentioned above must be strictly followed during the supply of materials.
